Dear Mr Scott:-

Referring to your letter of the 5th inst, in the matter of preliminary work at McIntosh Indian Boarding School, I wish to thank you for the authority given for the clearing of approximately forty acres and the blazing of a trail from the station to the school. In connection with the same matter I wish to state the following.

Your remarks about the docks and slide have been noted and we will govern ourselves accordingly.

The clearing of the land in our estimation and according to work already done will cost approximately \$110.00 an acre, making a total of about \$4.400 for the forty acres required. As already stated, the site of the intended school and surroundings are thickly wooded and the work of clearing is extremely difficult, but this work has to be done for the protection of the school from fire and also for the purpose of having land for cultivation.

The temporary shelters referred to are exclusively for the use of the men presently working on the site and cost from \$500 to \$600.


As you are aware, the Oblate Fathers have already spent a considerable amount of money at McIntosh for preliminary work and I take the liberty, in the name of Very Rev. Fr Beys O.M.I., of asking for an advance of \$4,000. I herewith enclose salary sheets and vouchers for material already received and used. The total amount is \$2354.25 which partly accounts for the request of an advance.

 EXTRACT FROM LETTER OF MR. FRANK EDWARDS, INDIAN AGENT, KENORA, DATED JANUARY 10, 1929, ON HIS INSPECTION OF THE MCINTOSH INDIAN RESIDENTIAL SCHOOL.

The Principal showed me Dept. letter 130-7-9, of October 5th last, re appropriation of \$2000 for deepening the culvert under the C.N. Ry. The Principal informs me that he gave the Father Provincial, in October or November, 1927, a copy of a contract which had been given him by Mr. Fred McIntosh, who was the Divisional Engineer on that section of the railroad, and in which it was stated that the Railway authorities would see to it that the water in the culvert would be at least 4 feet deep. I would suggest, therefore, that you ascertain if this work should not be done by the Railway, without any charge to our Department. It would be cheaper and better to have the work done in March before the ice goes out instead of in June. There is only 12 inches of water, in the culvert at the present time.
