

Dear Mr. Phelan:

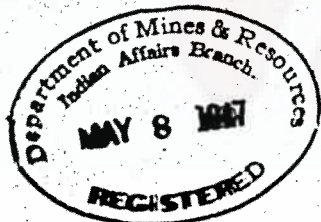
In a letter received this morning from the above school I am informed that the whole herd has been condemned by the veterinary surgeon. For the time being it will be necessary to have all the milk pasteurized, which will entail a great deal of work, but which cannot be considered as a solution of the problem. The present herd will have to be killed and a new one purchased.

The principal asks the Department to study this problem and supply the number of cows that it will be necessary for the school to buy.

You will likely receive a letter from your Kenora agent regarding this matter.

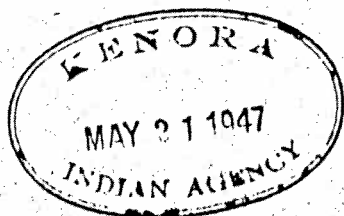

Memorandum:

DEPUTY MINISTER

A report has been received from Indian Agent Paterson, Kenora, Ontario, indicating that owing to the outbreak of Bangs' disease among the cattle at the Kenora Indian Residential School, it will be necessary to slaughter the whole herd.

The Kenora Residential School has an enrolment of 85 pupils and the Agent reports that ten head of milking cows are required to provide the requirements of the institution.

It has not been our general practice to purchase cattle for Indian Residential Schools, but owing to the special circumstances in the present case, I feel that an exception should be made.

I would, therefore, appreciate it if you would approve the purchase of ten head of milking cows for the Kenora School.

Re: Kenora R.C. Indian Residential School

Receipt is acknowledged of your letter dated the 29th ultimo, file 465-14(El) in connection with quantity of milk obtained from the dairy herd at this school.

At the present time only 4 cows are milking, and three will freshen in the next two months. These four produce eight gallons of milk daily. This eight gallons plus ten gallons of whole powdered milk is served to the pupils each day.

The average consumption per pupil is 1.4 pints each day.
